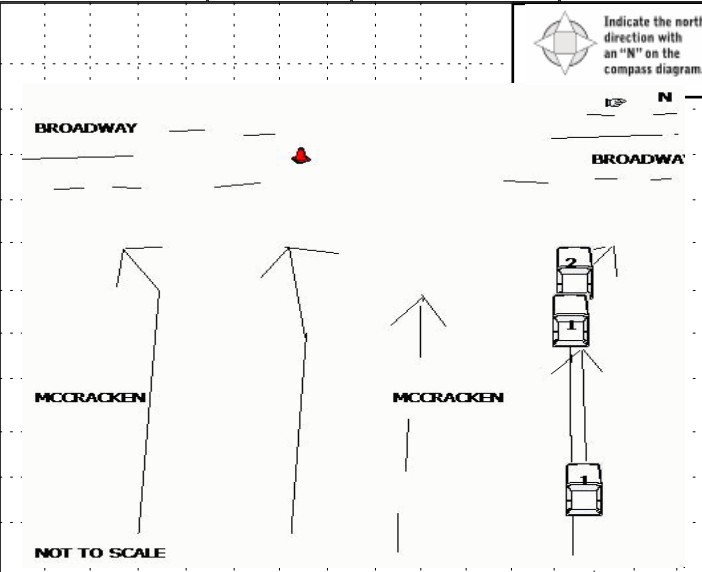

NARRATIVE

THE DRIVER OF UNIT 1 WAS STOPPED DIRECTLY BEHIND UNIT 2 IN THE RIGHT CURB LANE ON MCCRACKEN AT BROADWAY TRAFFIC LIGHT WAITING FOR GREEN LIGHT. UNIT 2 WAS STOPPED DIRECTLY IN FRONT OF UNIT 1 WAITING IN TRAFFIC FOR GREEN LIGHT. THE DRIVER OF UNIT 1 ACCIDENTALLY ACCELERATED AND STRUCK UNIT 2 IN THE REAR WITH UNIT 1'S FRONT AUTO.
