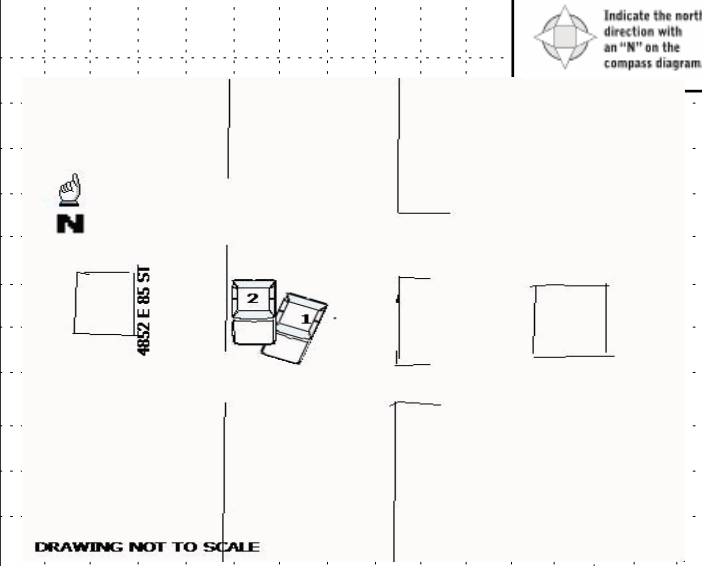

UNIT 2 BELIEVED UNIT 1 WAS TURNING LEFT IN A DRIVEWAY WHEN UNIT 2 CONTINUED TO PASS UNIT 1 WHEN UNIT 1 TURNED RIGHT AND STRUCK UNIT 2.
