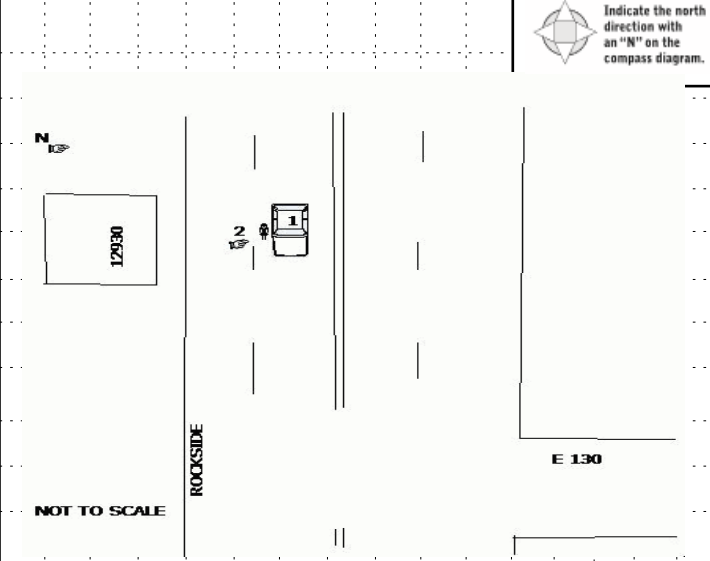

NARRATIVE

UNIT 1 WAS E/B ON ROCKSIDE IN LEFT LANE. UNIT 2 (PEDESTRIAN) ATTEMPTED TO CROSS ROCKSIDE N/B AT 12930 AND ENTERED THE ROADWAY. UNIT 2 WAS THEN STRUCK BY THE RIGHT SIDE MIRROR. UNIT 1 CONTINUED AND FLED SCENE. VIDEO FROM SECURITY CAMERAS AT 13001 ROCKSIDE WAS ABLE TO CAPTURE THE SUBJECT VEHICLE. THE ACCIDENT ITSELF WAS BLOCKED BY AN OBSTRUCTION AFTER REVIEWING CITY CAMERAS, NO SUSPECT VEHICLE WAS LOCATED.
