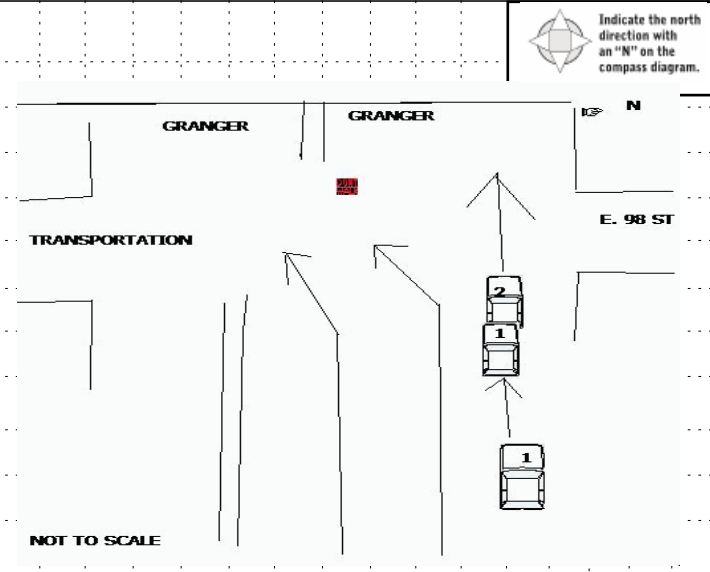

NARRATIVE
THE DRIVER OF UNIT 2 WAS STOPPED W/B ON GRANGER RD AT TRANSPORTATION TRAFFIC LIGHT WAITING FOR THE LIGHT. THE DRIVER OF UNIT 1 WAS W/B DIRECTLY BEHIND UNIT 2 AND WAS SLOWING DOWN IN TRAFFIC TO STOP. UNIT 1 APPLIED BREAKS BUT HIS VEHICLE ACCELERATED AND STRUCK UNIT 2 IN THE REAR WITH UNIT 1'S FRONT AUTO. THE DRIVER OF UNIT 1 WAS CITED FOR FAILURE TO MAINT ASSURED CLEAR DISTANCE HEAD.
