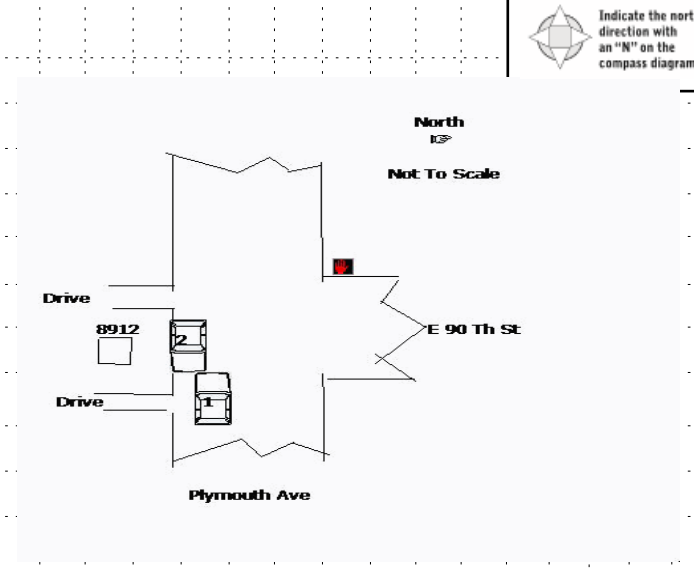

UNIT # 1 WAS TRAVELING WEST IN EASTBOUND LANES AT 8912 PLYMOUTH. UNIT # 2 WAS LEGALLY PARKED FACING EAST AT 8912 PLYMOUTH. AS A RESULT, THE LEFT FRONT OF UNIT # 1 COLLIDED WITH THE LEFT FRONT OF UNIT # 2. BOTH UNITS WERE AT FINAL REST UPON ARRIVAL.
NOTE: DRIVER OF UNIT # 1 STATED, HE HAD STOPPED ON SOUTH SIDE OF ROAD AND STARTED TO DRIVE AGAIN. (POINTING TO SNOW ON GROUND STATED) WAS NOT ABLE TO STEER OVER, IT JUST KEPT GOING STRAIGHT. BWC
