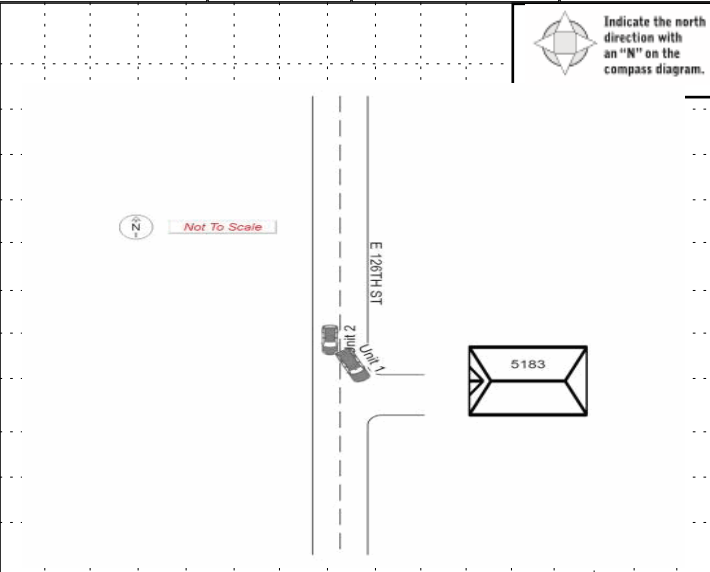

DRIVER OF UNIT 2 DID NOT HAVE PROOF OF INSURANCE ON SCENE AND WAS ADVISED TO PROVIDE IT AT THE EARLIEST OPPORTUNITY.

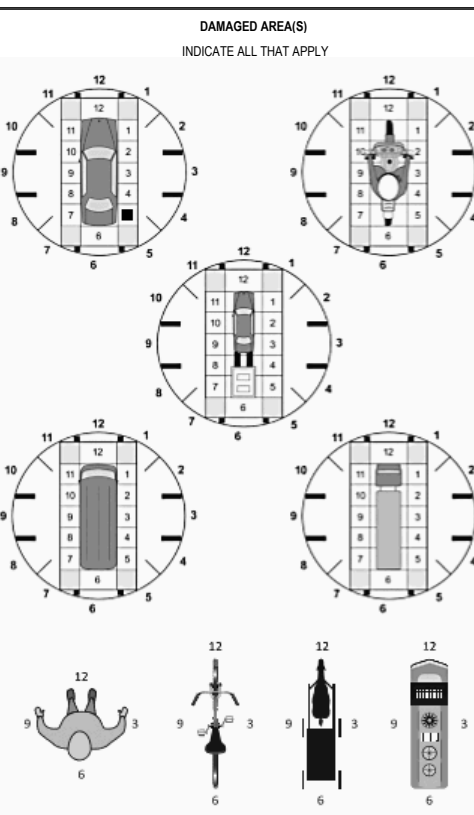
