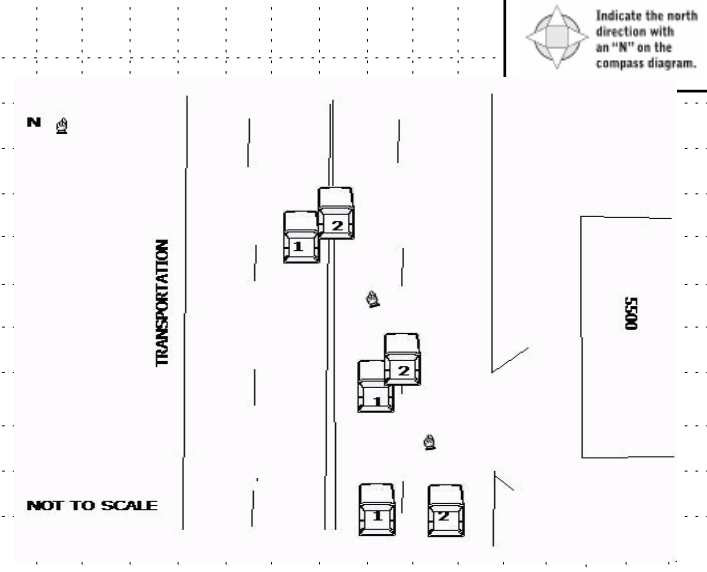

UNIT 1 WAS N/B ON TRANSPORTATION IN LANE 2. UNIT 2 WAS ALSO N/B TRANSPORTATION IN CURB LANE. UNIT 2 STATES ANOTHER VEHICLE HAD MADE A U-TURN AHEAD OF HIM INTO THE DRIVE OF 5500 TRANSPORTATION AND PULLED OUT IN FRONT OF UNIT 2. UNIT 2 SWERVED TO THE LEFT TO AVOID STRIKING THE VEHICLE WHEN UNIT 2 FAILED TO YIELD UNIT 1 AND UNIT 2 STRUCK UNIT 1 ON FRONT RIGHT. DRIVER OF UNIT 1 STATES SHE DID NOT OBSERVE A VEHICLE MAKE A U-TURN NOR PULL OUT IN FRONT OF UNIT 2.
