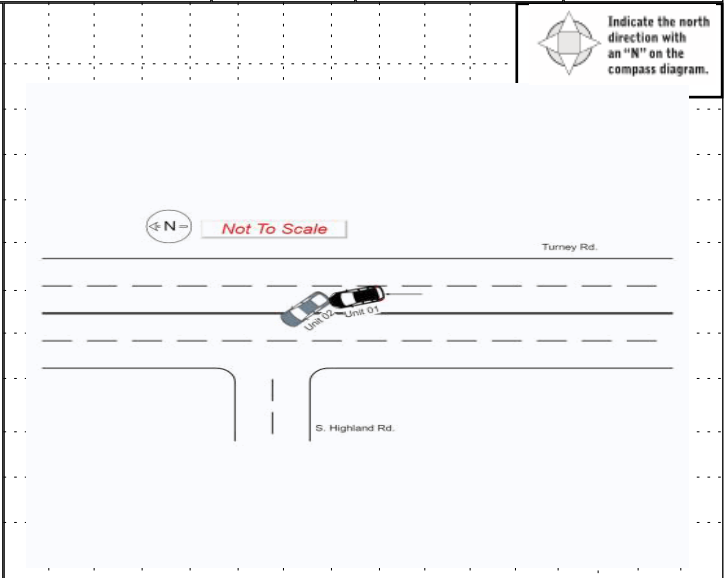

UNIT 01 STATED HE TURNED NORTH BOUND ONTO TURNEY RD. FROM THORNTON AVE. AND WAS STRUCK BY UNIT 02, IN AN UNKNOWN MANNER. DUE TO UNIT 01 AND UNIT 02 HAVING OPPOSING STORIES, OFFICERS WERE UNABLE TO DETERMINE FAULT. BASED ON THE DAMAGE OF THE VEHICLES, OFFICERS BELIEVE UNIT 01 STRUCK UNIT 02 FROM THE REAR.
