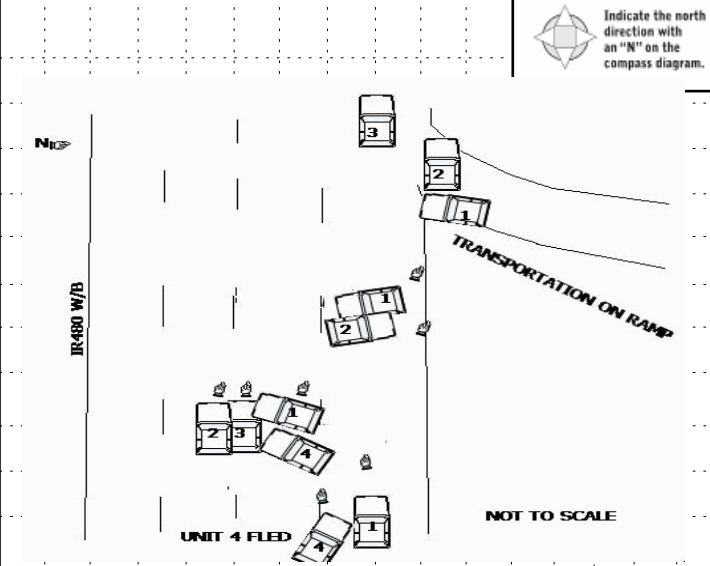

UNIT 1 WAS W/B ON IR480 IN LANE 1 AT TRANSPORTATION. UNIT 2 WAS IN LANE 3 SLIGHTLY AHEAD OF UNIT 1. UNIT 3 WAS ALONGSIDE OF UNIT 2 IN LANE 2. UNIT 4 WAS REPORTED AS DRIVING RECKLESSLY CHANGING LANES BEHIND UNIT 1. UNIT 4 THEN ENTERED INTO UNIT 1 LANE AND STRUCK UNIT 1 ON DRIVERS SIDE FORCING UNIT 1 AND UNIT 4 TO STRIKE UNIT 3 ON DRIVERS SIDE. FORCING UNIT 3 INTO UNIT 2.
