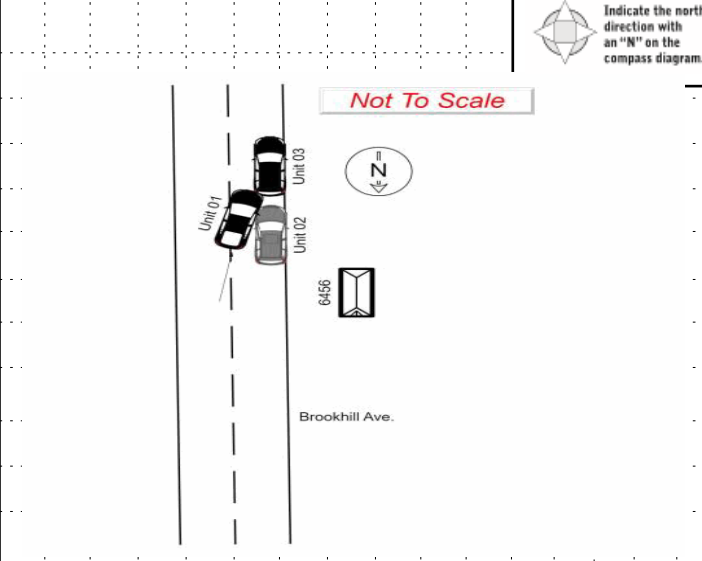

BASED ON SKID MARKS AND VEHICLE DAMAGE, IT APPEARED FRONT END DEFECTS MAY HAVE CAUSED UNIT 01 TO SWERVE RIGHT.
