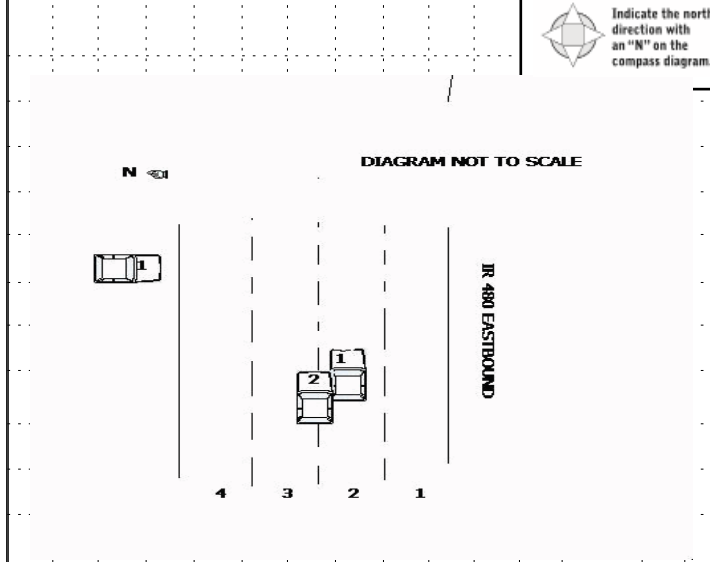

DRIVER OF UNIT #1 STATED SHE WAS TRAVELING EASTBOUND ON IR 480 JUST WEST OF MP 22 IN THE #2 LANE WHEN UNIT #2, WHICH WAS IN THE #3 LANE, VEERED INTO THE #2 LANE AND STUCK UNIT #1 ON THE DRIVER'S SIDE MIRROR AREA CAUSING BOTH UNITS TO SPIN OUT AT WHICH TIME UNIT #2 STRUCK UNIT #1 A SECOND TIME ON THE DRIVER'S SIDE AND UNIT #1 TRAVELED INTO THE GRASSY MEDIAN AND UNIT #2 CONTINUED EASTBOUND AND EXITED AT GRANGER RD.
