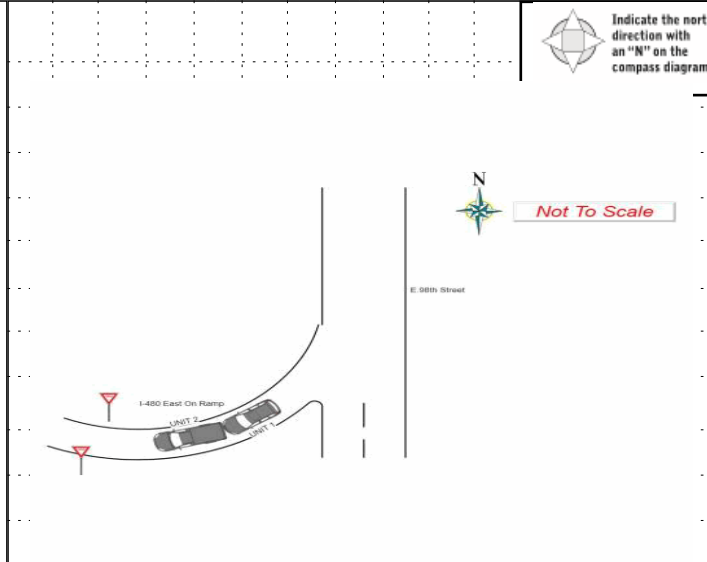

UNIT 2 WAS TRAVELING SOUTH BOUND ON I-480 EAST ON RAMP OFF OF TRANSPORTATION BLVD.. UNIT 2 YIELDED TO ONCOMING TRAFFIC BEFORE CONTINUING ON THE RAMP. UNIT 1 WAS ALSO TRAVELING IN THE SAME DIRECTION. UNIT 1 DID NOT STOP IN TIME FOR UNIT 2 AND STRUCK UNIT 2 IN THE REAR CAUSING MINOR DAMAGE. UNIT 1 HAD MINOR DAMAGE TO THE FRONT RIGHT PASSENGER SIDE. UNIT 2 SUFFERED MINOR DAMAGE TO THE BACK RIGHT PASSENGER SIDE.
