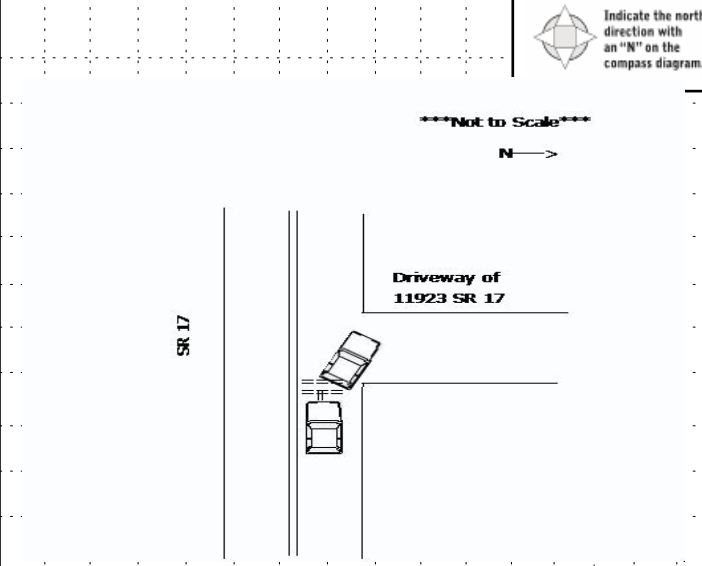

DRIVER OF UNIT #1 STATED SHE WAS TRAVELLING ON SR 17 W/B WHEN SHE SLOWED DOWN TO TURN INTO THE DRIVEWAY OF 11923. AS SHE SLOWED AND TURNED INTO THE DRIVEWAY APRON, HER VEHICLE WAS STRUCK BY UNIT #2. DRIVER OF UNIT #2 STATED HE WAS TRAVELLING DIRECTLY BEHIND UNIT #1 WHEN SHE ABRUPTLY SLOWED DOWN AND WITHOUT SIGNALING TURNED INTO THE DRIVEWAY OF 11923 SR 17. THE SNOW PLOW ON UNIT #2 STRUCK THE REAR OF UNIT #1 CAUSING VERY MINOR DAMAGE. THE PLOW SUFFERED NO OBVIOUS DAMAGE. SEE OH 2
