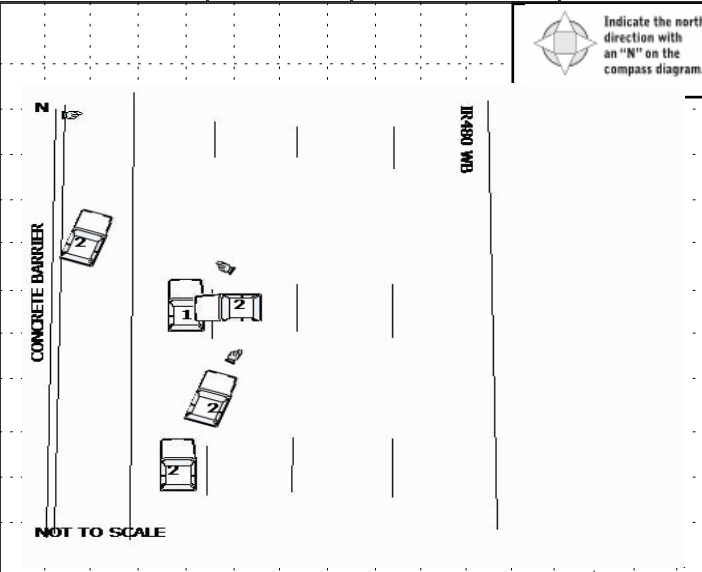

NARRATIVE

UNIT 1 WAS W/B ON IR480 NEAR BROADWAY IN LEFT LANE. UNIT 2 WAS SECOND CAR TO REAR OF UNIT 1. TRAFFIC SLOWED AND UNIT 2 SWERVED TO THE RIGHT TO AVOID STRIKING THE VEHICLE IN FRONT OF HER. UNIT 2 THEN ATTEMPTED TO RETURN BACK INTO THE LEFT LANE, LOST CONTROL AND SPUN SIDeways STRIKING UNIT 1 ON DRIVER'S SIDE. UNIT 2 THEN LOST CONTROL AND STRUCK CONCRETE BARRIER ON DRIVER'S SIDE LEFT. THE MVA WAS WITNESSED BY VEHICLE IN FRONT OF UNIT 2 ORIGINALLY.
