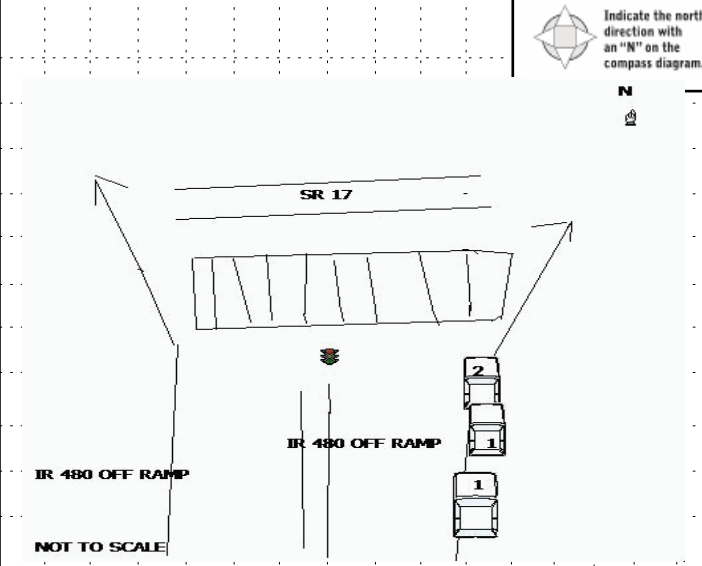

THE DRIVER OF UNIT 2 WAS STOPPED ON THE IR 480 EAST OFF RAMP AT THE S.R. 17 FOR A RED TRAFFIC LIGHT. THE DRIVER OF UNIT 1 WAS DIRECTLY BEHIND UNIT 2. THE DRIVER OF UNIT 1 FAILED TO MAINTAIN ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT 2 IN THE REAR WITH THE FRONT OF UNIT 1. THE DRIVER OF UNIT 1 LEFT UNVERIFIED FIRST AND LAST NAME AND PHONE NUMBER. UNIT 1 LEFT THE SCENE PRIOR POLICE ARRIVAL.


