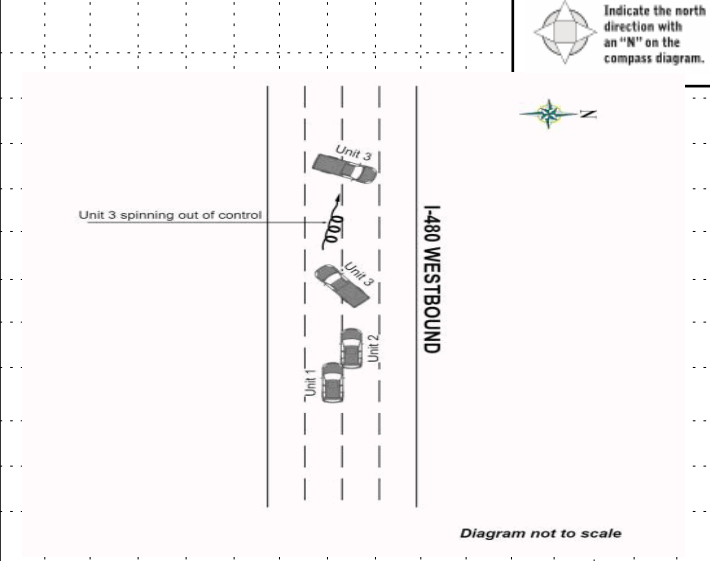

UNIT 3 WAS ENTERING TRAFFIC ONTO 480W FROM GRANGER RD. UNIT 3 WAS TRAVELING WESTBOUND IN THE NUMBER 3 LANE. UNIT 2 WAS TRAVELING WESTBOUND IN THE NUMBER 2 LANE. UNIT 3 LOST CONTROL AND SPUN OUT INTO THE HIGHWAY LANES. UNIT 2 SWERVED TO AVOID UNIT 3 AND WAS STRUCK BY UNIT 1.
