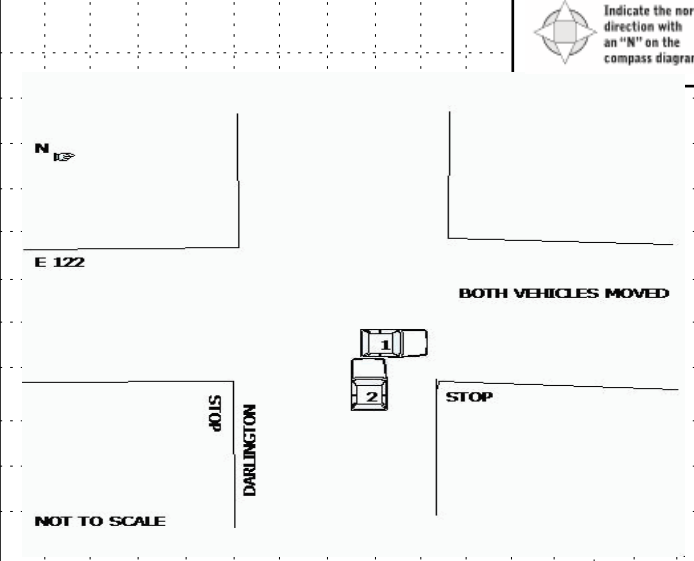

UNIT 1 STATES HE WAS N/B ON E 122 AT DARLINGTON AND STOPPED FOR STOP SIGN. UNIT 2 STATES SHE WAS W/B ON DARLINGTON AND STOPPED FOR STOP SIGN. BOTH ADVISED THEY ARRIVED AT SAME TIME BOTH PROCEEDED THROUGH THE INTERSECTION WHEN UNIT 1 WAS STRUCK ON PASSENGER REAR BY UNIT 2. UNIT 2 STATES UNIT 1 HAD RIGHT TURN SIGNAL ACTIVATED SO SHE PROCEEDED. IF BOTH ARRIVED SIMULTANEOUSLY THEN UNIT 1 SHOULD HAVE YIELDED TO UNIT 2.
