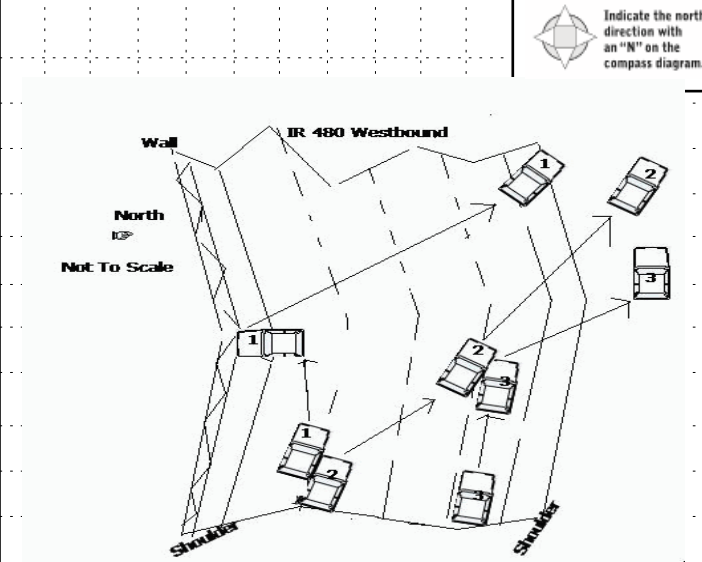

NARRATIVE

UNIT 1 WAS IN THE INSIDE, UNIT 2 WAS IN THE MIDDLE INSIDE, AND UNIT 3 WAS IN THE OUTSIDE LANE TRAVELING WEST ON IR 480 NEAR MILE POST 22.4. UNIT 1 AND UNIT 2 COLLIDED. UNIT 1 ROTATED INTO THE MEDIAN WALL, THEN TRAVELED OFF THE ROADWAY TO THE RIGHT COLLIDING WITH THE EMBANKMENT. UNIT 2 WAS DIRECTED TO THE OUTSIDE LANE AND COLLIDED WITH UNIT 3. UNIT # 2 AND UNIT # 3 TRAVELED OFF THE RIGHT SIDE OF ROADWAY.

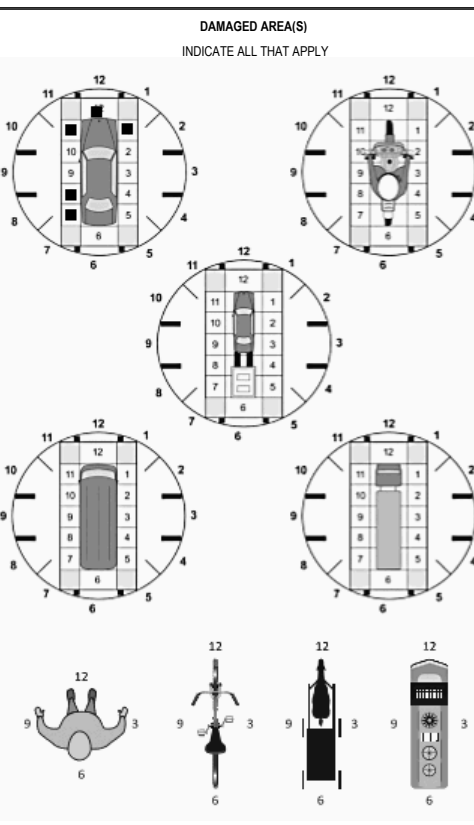
