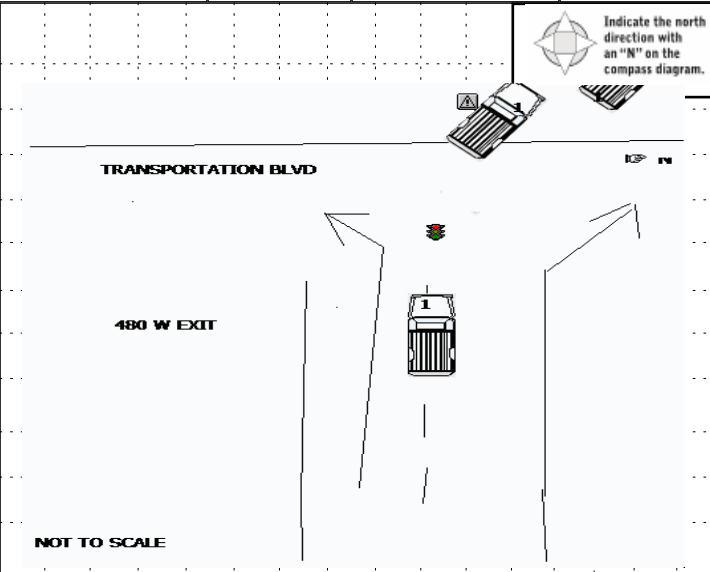

NARRATIVE  
THE DRIVER OF UNIT 1 WAS TRAVELING AT HIGH RATE OF SPEED EXITING I-480 WEST EXIT ONTO TRANSPORTATION BLVD. THE DRIVER OF UNIT 1 FAILED TO CONTROL HIS AUTO AND DROVE W/B ACROSS ALL LANES OF TRANSPORTATION BLVD AND UP OVER THE CURB TRAVELING OFF THE ROAD TO THE LEFT. UNIT 1 THEN STRUCK THE CROSSWALK DEVICE POLE, KNOCKING IT TO THE GROUND, WITH UNIT 1'S LEFT SIDE AND THEN CAME TO FINAL REST IN THE FIELD.
