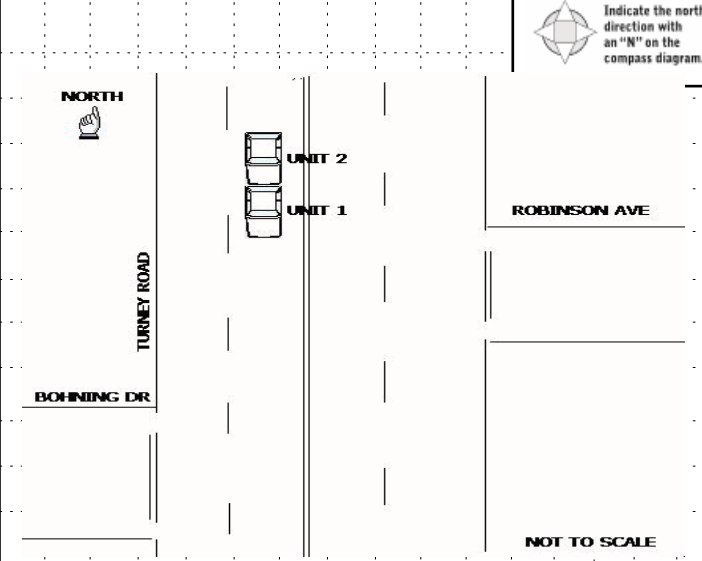

ROADWAY DIVIDED

NARRATIVE
UNIT ONE WAS TRAVELING S/B ON TURNEY ROAD, IN THE CENTER LANE. AS UNIT ONE APPROACHED THE INTERSECTION OF TURNEY ROAD AND ROBINSON AVENUE, UNIT ONE STOPPED FOR TRAFFIC AND ACTIVATED THEIR LEFT TURN SIGNAL. UNIT TWO WAS ALSO TRAVELING S/B ON TURNEY ROAD, DIRECTLY BEHIND UNIT ONE. THE DRIVER OF UNIT TWO DID NOT SEE UNIT ONE STOPPED IN TRAFFIC AND DID NOT ALLOW FOR ASSURED CLEAR DISTANCE AHEAD; CAUSING UNIT TWO TO STRIKE THE REAR OF UNIT ONE IN A REAR-END COLLISION.
