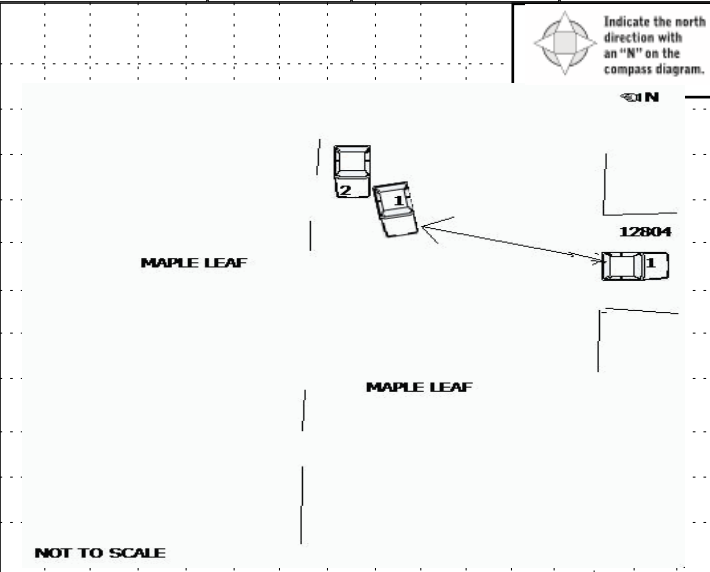

THE DRIVER OF UNIT 1 WAS BACKING OUT FROM 12804 MAPLE LEAF DR. ONTO THE ROADWAY. UNIT 2 WAS LEGALLY PARKED UNOCCUPIED ON STREET FACING W/B. THE DRIVER OF UNIT 1 IMPROPERLY BACKED CAUSING UNIT 1 TO STRIKE UNIT 2 IN THE LEFT FRONT WITH UNIT 1'S RIGHT BUMPER.
