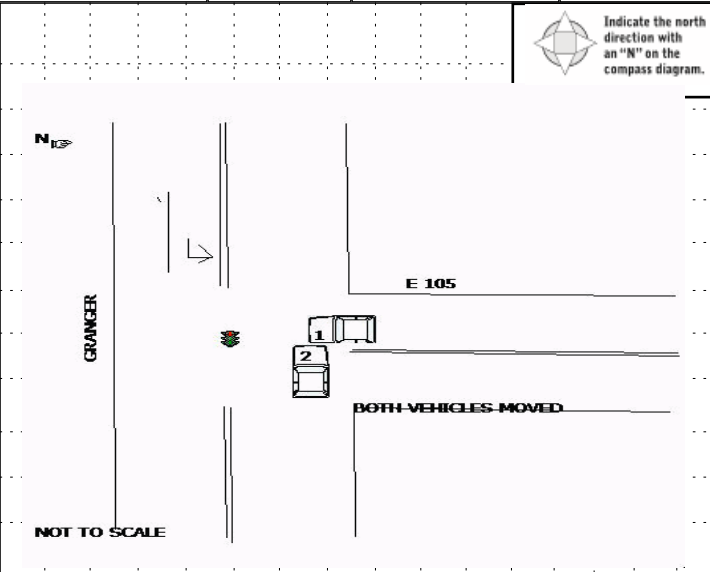

UNIT 1 WAS STOPPED ON E 105 AT GRANGER AT RED LIGHT. UNIT 2 WAS W/B ON GRANGER APPROACHING E 105. THE SIGNAL TURNED TO RED FOR UNIT 2. UNIT 1 THEN PROCEEDED FORWARD THRU GREEN LIGHT. UNIT 2 RAN THRU RED LIGHT AND STRUCK UNIT 1 ON DRIVER'S SIDE FRONT. UNIT 2 STATED SHE WAS BRAKING AND TRIED TO STOP BEFORE ENTERING INTERSECTION.
