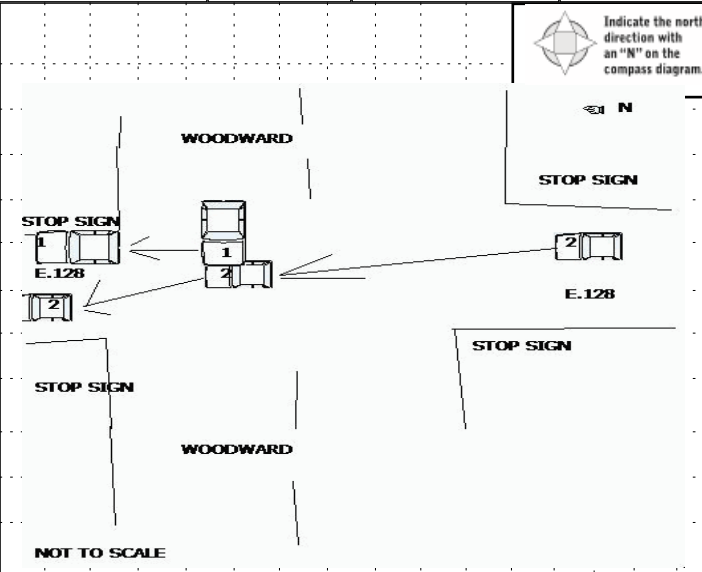

UNIT 1 WAS OBSERVED BY WITNESS TRAVELING E/B ON WOODWARD BLVD RAN THROUGH STOP SIGN WITHOUT STOPPING AT E. 128 STREET. UNIT 2 WAS TRAVELING S/B ON E. 128 STREET APPROACHING WOODWARD STOP SIGN. UNIT 1 WAS THEN OBSERVED STRUCK UNIT 2 IN RIGHT FRONT WITH UNIT 1'S FRONT LEFT BUMPER. DUE TO THE IMPACT, UNIT 1 HAS WINDSHIELD DAMAGE AND DRIVER'S WINDOW GLASS CRACK.

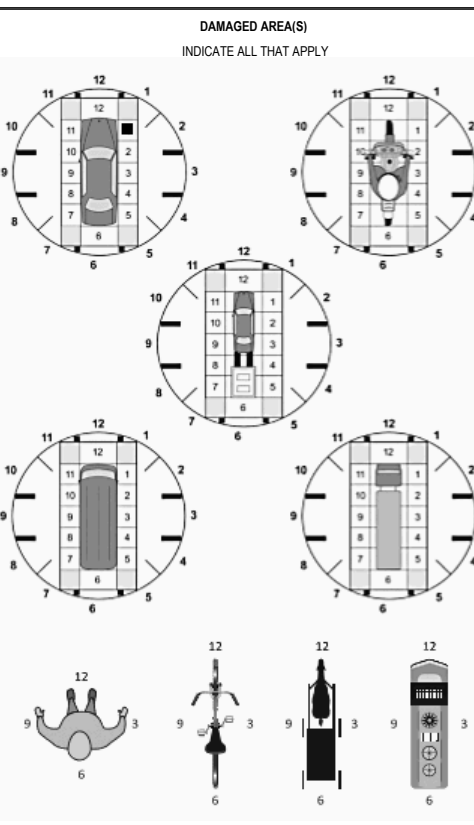
