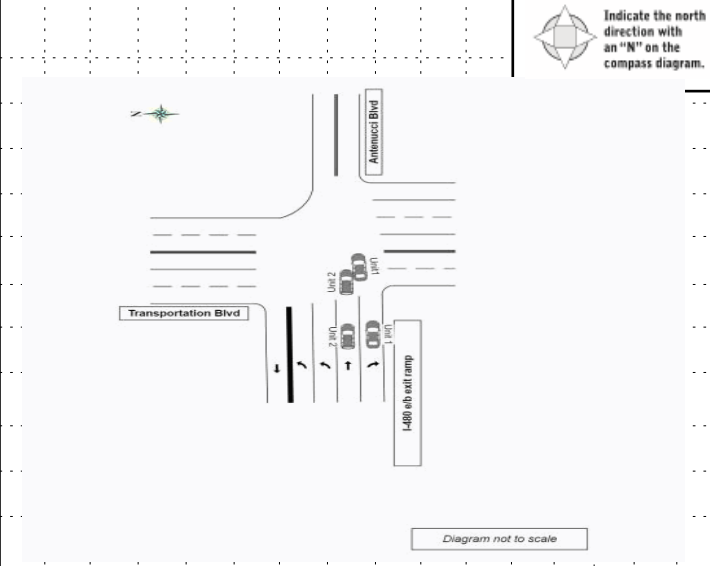

UNIT 1 WAS IN THE "RIGHT TURN ONLY" LANE ON THE I-480 E/B EXIT RAMP AT TRANSPORTATION BLVD. UNIT 2 WAS IN THE "STRAIGHT ONLY" LANE ON THE I-480 E/B EXIT RAMP AT TRANSPORTATION BLVD. UNIT 2 PROCEEDED THROUGH THE INTERSECTION TO CONTINUE STRAIGHT ONTO ANTENUCCI BLVD. UNIT 1 ENCREACHED INTO UNIT 2'S LANE. UNIT 1 AND UNIT 2 MADE CONTACT WITH EACH OTHER CAUSING MINOR DAMAGE.
