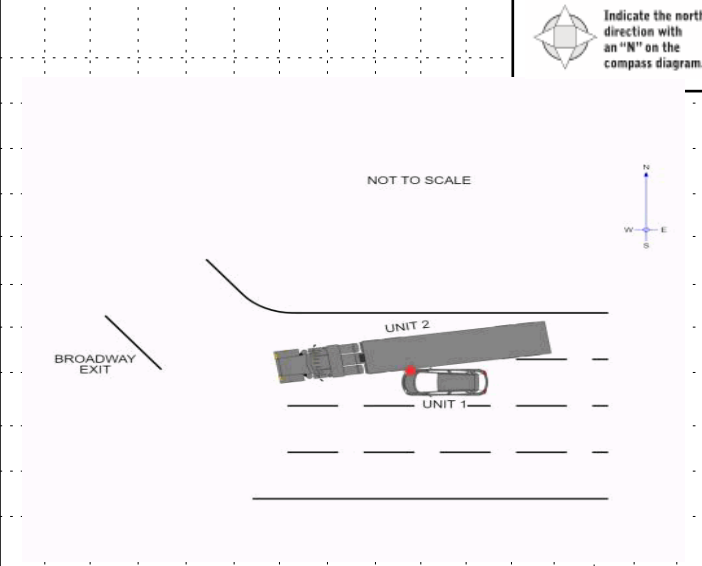

WHILE DOING THIS UNIT 2 STRUCK UNIT 1'S FRONT END AND FLED THE SCENE. UNIT 1 DESCRIBED UNIT 2 AS A SEMI WITH A TRAILER, UNKNOWN PLATE AND COLOR. EMS REFUSED.
