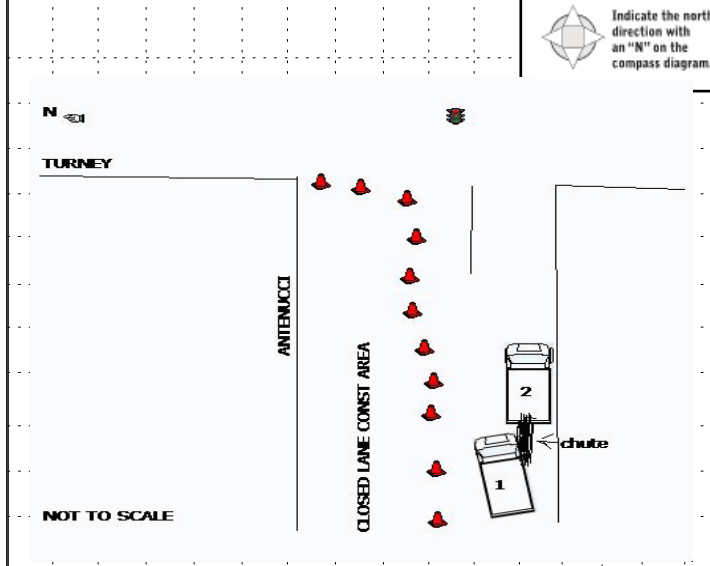

NARRATIVE
UNIT 2, CONCRETE TRUCK, WAS E/B ON ANTENUCCI JUST BEFORE TURNERY. UNIT 1 WAS BEHIND UNIT 2. UNIT 2 HAD JUST POURED CEMENT IN WORK AREA AND PULLED BACK OUT IN E/B LANE WITH THE CONCRETE CHUTE STILL EXTENDED. UNIT 2 CONTINUED E/B WITH HAZARDS ON AND SLOWED TO A STOP TO ALLOW TRAFFIC TO PASS AROUND HIM WHERE THE LANE WIDENED. UNIT 2 WAVED UNIT 1 TO PASS AROUND HIM. UNIT 1 THEN BEGAN TO PULL AROUND UNIT 2 BUT THE TOP RIGHT CORNER OF THE BOX TRUCK STRUCK THE EXTENDED CHUTE, RIPPING OPEN THE TOP.
