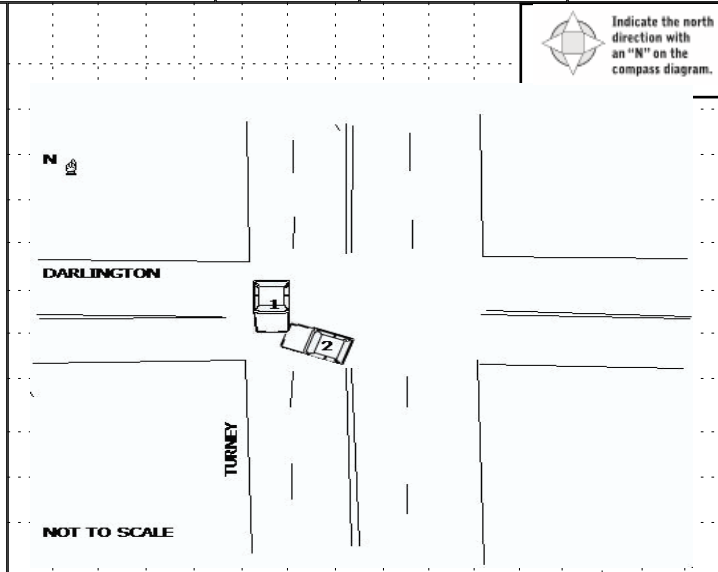

A VEHICLE IN LEFT LANE ON TURNEY S/B, STOPPED IN ORDER TO ALLOW UNIT 2 TO TURN LEFT. UNIT 2 THEN TURNED LEFT, FAILING TO YIELD UNIT 1, CAUSING UNIT 1 TO STRIKE UNIT 2 IN LEFT FRONT.
