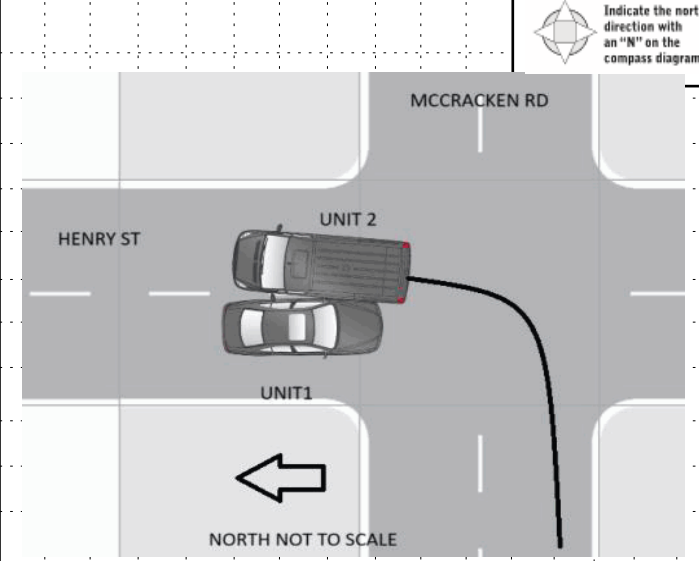

UNIT TWO WAS TRAVELING EASTBOUND ON MCCRACKEN RD. AND MADE A LEFT TURN ONTO HENRY ST. THE LEFT REAR OF UNIT TWO STRUCK THE LEFT FRONT OF UNIT ONE. AT THIS TIME, THE AT-FAULT DRIVER IS UNDETERMINED.
