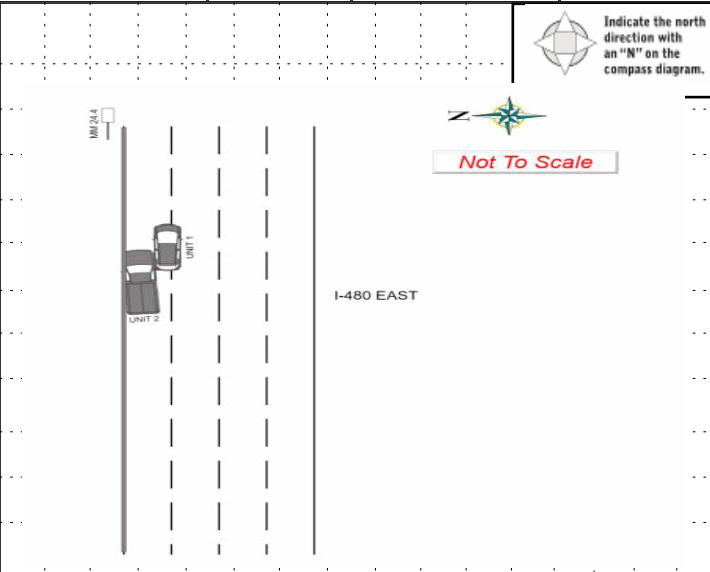

UNIT 1 AND UNIT 2 WERE TRAVELING EASTBOUND ON I-480. UNIT 2 WAS IN NUMBER 1 LANE AND UNIT 1 WAS IN NUMBER 2 LANE. UNIT 1 IMPROPERLY CHANGED LANES AND STUCK UNIT 2 IN THE PASSENGER FRONT WITH UNIT 1'S DRIVER BACK SIDE. MINOR DAMAGE TO BOTH AREAS. UNIT 2 MADE CONTACT WITH BARRIER ON DRIVER SIDE CAUSING A FLAT FRONT DRIVER SIDE TIRE.
