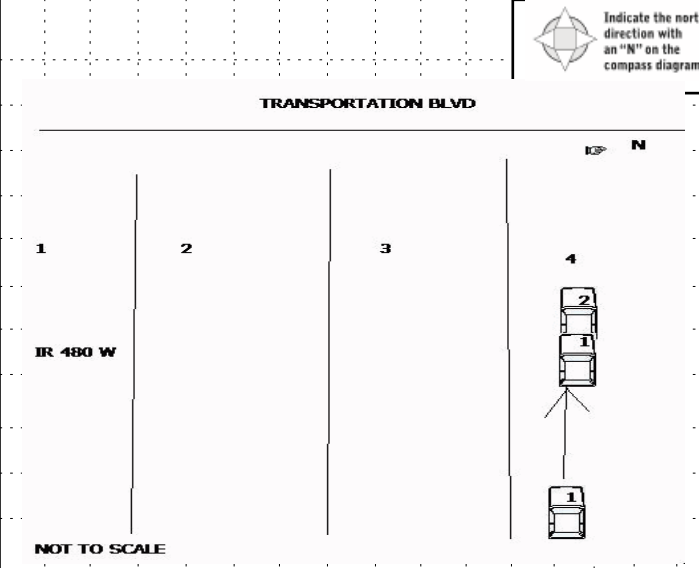

UNIT 1 THEN FAILED TO MAINTAIN ASSURED CLEAR DISTANCE AHEAD CAUSING UNIT 1 TO STRIKE UNIT 2 IN THE REAR BUMPER WITH UNIT 1'S FRONT BUMPER. UNIT 1 BRIEFLY STOPPED AND LEFT THE SCENE WITHOUT PROVIDING HIS INFORMATION.
