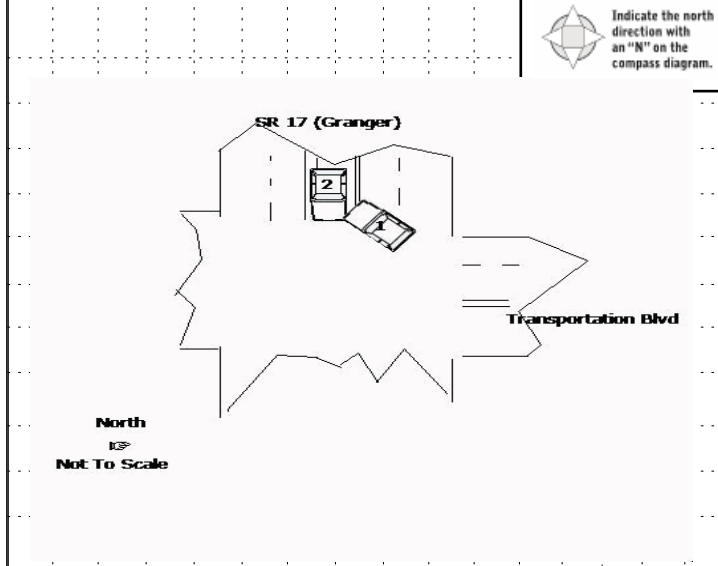

UNIT # 1 WAS TRAVELING SOUTH ON TRANSPORTATION IN THE OUTSIDE LANE AT GRANGER RD. UNIT # 2 WAS TRAVELING EAST IN THE INSIDE LANE ON SR 17(GRANGER) AT TRANSPORTATION. UNIT # 1 ATTEMPTED A RIGHT TURN TO TRAVEL WEST ON GRANGER RD. AS A RESULT, UNIT # 1 TRAVELED THROUGH THE OUTSIDE, INSIDE LANE, AND LEFT OF CENTER. THE LEFT FRONT COLLIDED WITH THE LEFT FRONT OF UNIT # 2. BOTH UNITS WERE MOVED FROM FINAL REST.
