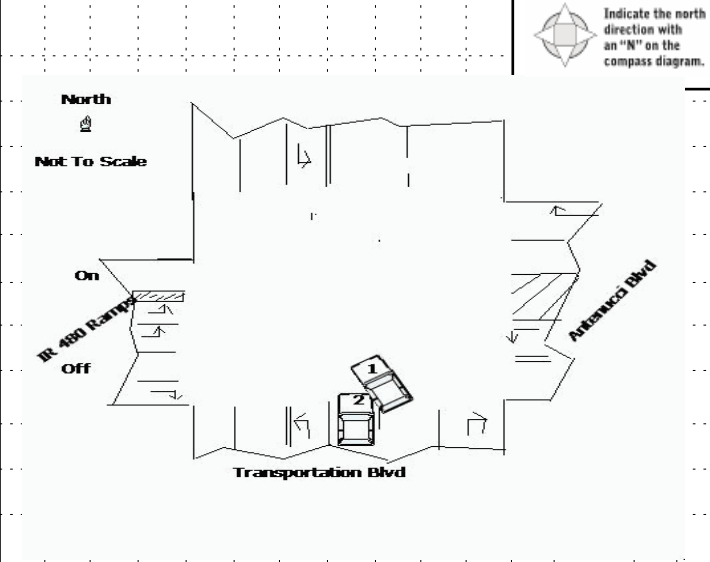

UNIT#1 WAS TRAVELING NORTH IN THE MIDDLE OUTSIDE LANE ON TRANSPORTATION BLVD AT ANTENUCCI BLVD. UNIT#2 WAS TRAVELING NORTH IN THE MIDDLE INSIDE LANE ON TRANSPORTATION BLVD AT ANTENUCCI BLVD. UNIT#1 CHANGED LANES AND ATTEMPTED TO TURN LEFT ON THE E/B IR 480 RAMP. AS A RESULT, THE LEFT SIDE OF UNIT#1 COLLIDED WITH THE RIGHT FRONT OF UNIT#2. UNITS PARKED UPON ARRIVAL.

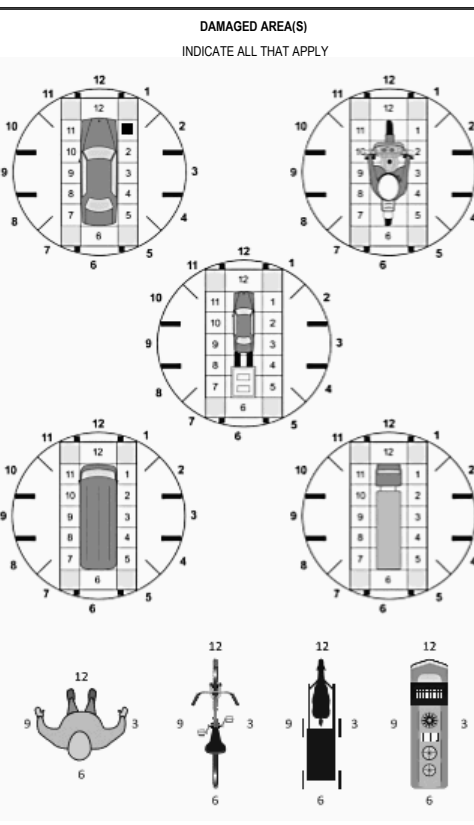
