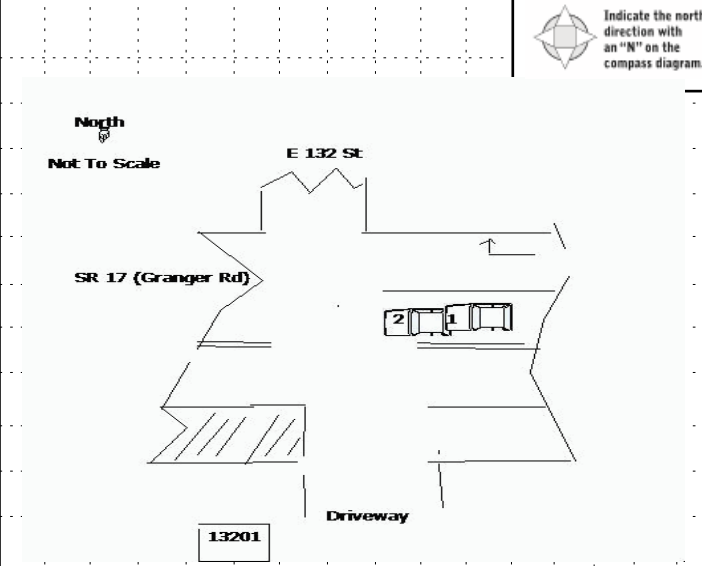

UNIT#1 WAS TRAVELING EAST IN THE INSIDE LANE NEAR 13201 SR 17 (GRANGER RD) DIRECTLY BEHIND UNIT#2. UNIT#2 STOPPED FOR TRAFFIC PRIOR TO A LEFT TURN. AS A RESULT, THE FRONT OF UNIT#1 COLLIDED WITH THE BACK OF UNIT#2. BOTH UNITS WERE MOVED FROM FINAL REST AND PARKED IN THE LOT OF 13201 GRANGER RD UPON ARRIVAL.
