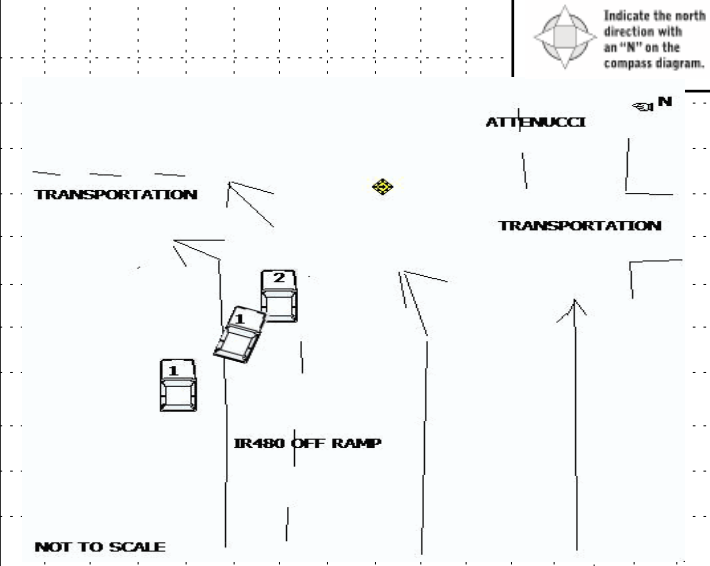

THE DRIVER OF UNIT 1 WAS EXITING FROM IR480 AND ATTENUCCI EXIT RAMP IN THE CURVE LEFT TURNING LANE TURNING N/B ONTO TRANSPORTATION. THE DRIVER OF UNIT 2 WAS TO THE RIGHT IN THE 2ND LEFT TURNING LANE TURNING N/B ONTO TRANSPORTATION. THE DRIVER OF UNIT 1 THEN MADE IMPROPER TURN BY MERGING INTO UNIT 2'S LANE STRIKING UNIT 2 IN THE LEFT REAR BUMPER WITH UNIT 1'S FRONT RIGHT BUMPER.
