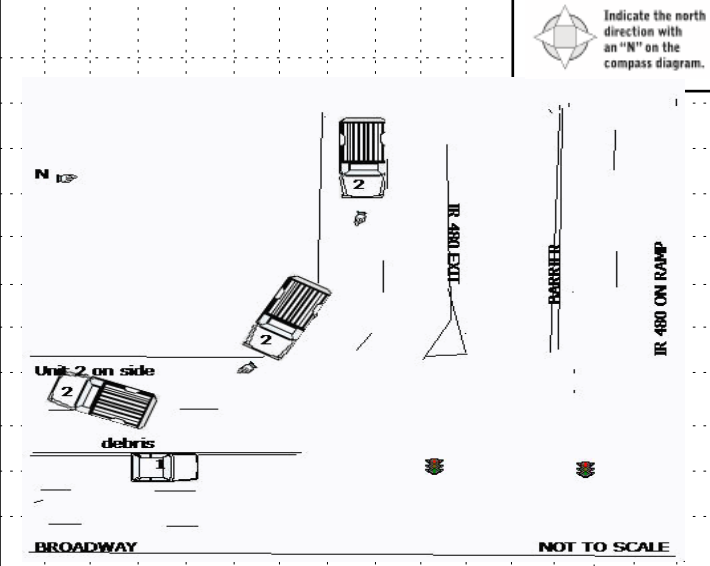

NARRATIVE

UNIT 2 WAS EXITING IR480 AT BROADWAY. UNIT 1 WAS STOPPED ON BROADWAY AT TRAFFIC LIGHT AT IR480. WHILE UNIT 2 WAS COMING DOWN THE RAMP, DRIVER STATES HE LOST HIS BRAKES AND WAS UNABLE TO STOP. UNIT 2 THEN SWERVED TO THE RIGHT TO AVOID STRIKING VEHICLES AHEAD OF HIM. UNIT 2 THEN WENT OFF ROAD ON THE RIGHT, STRUCK A CURB AND WHEN ATTEMPTING TO TURN RIGHT ONTO BROADWAY, UNIT 2 ROLLED ONTO DRIVER'S SIDE, SPILLING HIS LOAD OF SCRAP METAL. SEE OH -2
