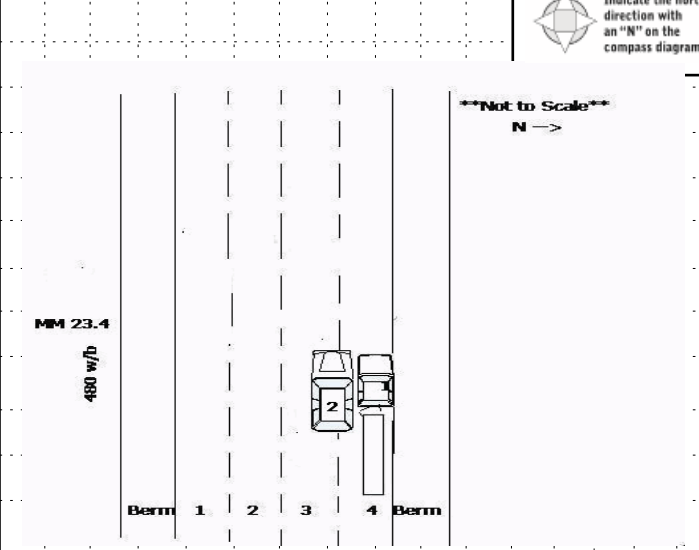

UNIT 2 FAILED TO REMAIN IN ITS LANE OF TRAVEL AND SIDE WIPED UNIT 1, DAMAGING THE DRIVERS DOOR MIRROR. UNIT 2 CONTINUED W/B ON IR 480 TO IR 77 WITHOUT STOPPING. DRIVER OF UNIT 1 STATED UNIT 2 WAS SWERVING IN AND OUT OF LANES OF TRAFFIC.
