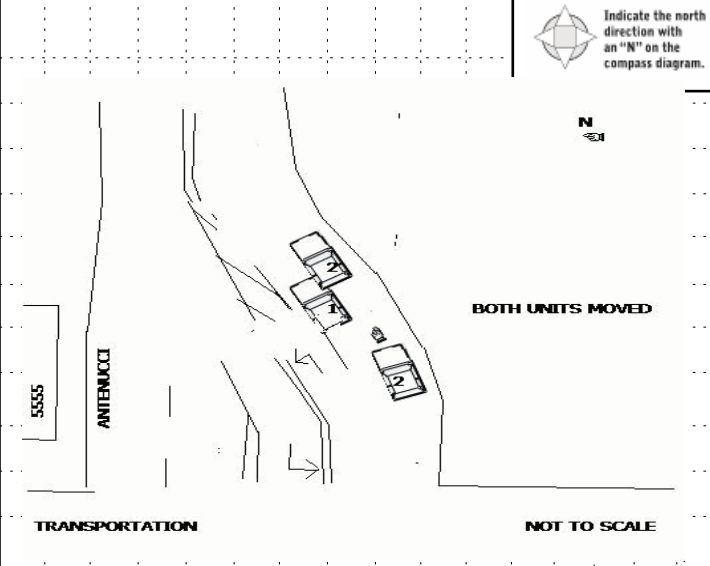

UNIT 1 WAS E/B ON ANTENUCCI AT 5555 TRANSPORTATION. UNIT 2 WAS BEHIND UNIT 1. UNIT 1 DRIFTED TO THE LEFT, IN HER LANE, TO AVOID A LARGE PUDDLE OF WATER IN ROADWAY. UNIT 2 THEN PASSED TO THE RIGHT OF UNIT 1 CAUSING UNIT 1 TO STRIKE UNIT 2. UNIT 2 BELIEVED UNIT 1 WAS ATTEMPTING TO TURN LEFT INTO 5555 CAUSING HER TO PASS ON THE RIGHT. NEITHER PARTY INDICATED A SIGNAL WAS USED NOR THAT UNIT 1 STOPPED TO TURN.
