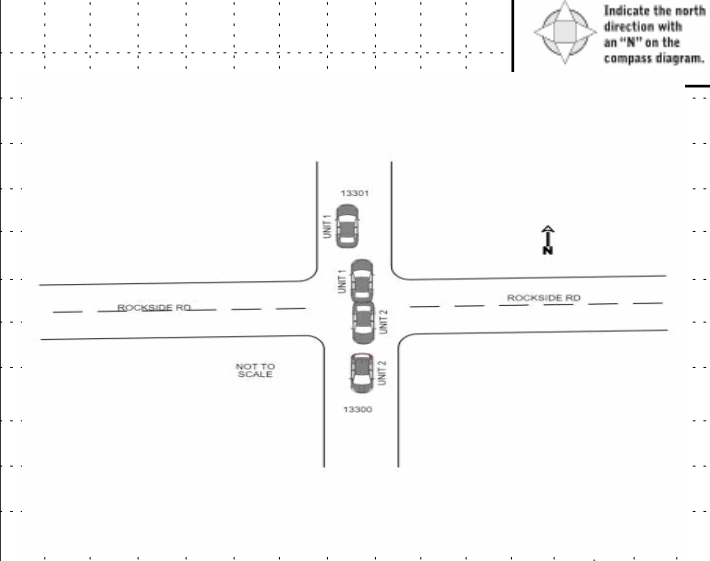

UNIT 1 HAS A SIGNIFICANT DAMAGE TO THE REAR BUMPER AND BUSTED REAR WINDSHIELD FROM THE IMPACT. UNIT 1 SUSTAINED MINOR DAMAGE ON THE REAR RIGHT BUMPER.

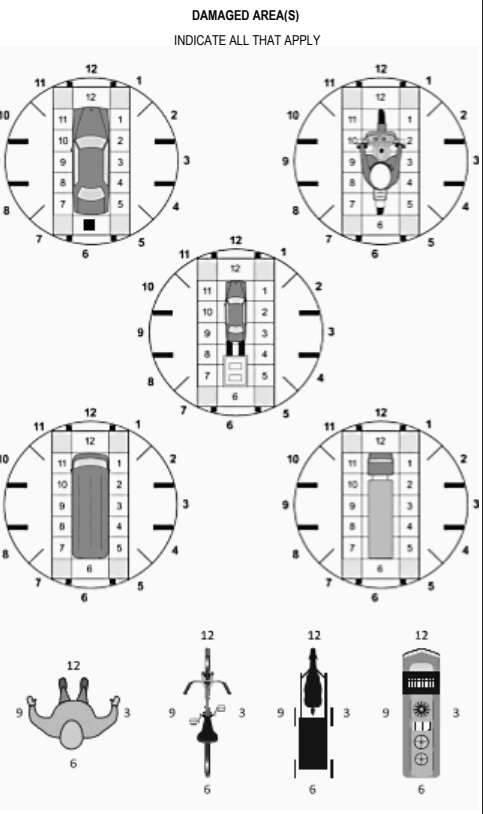
