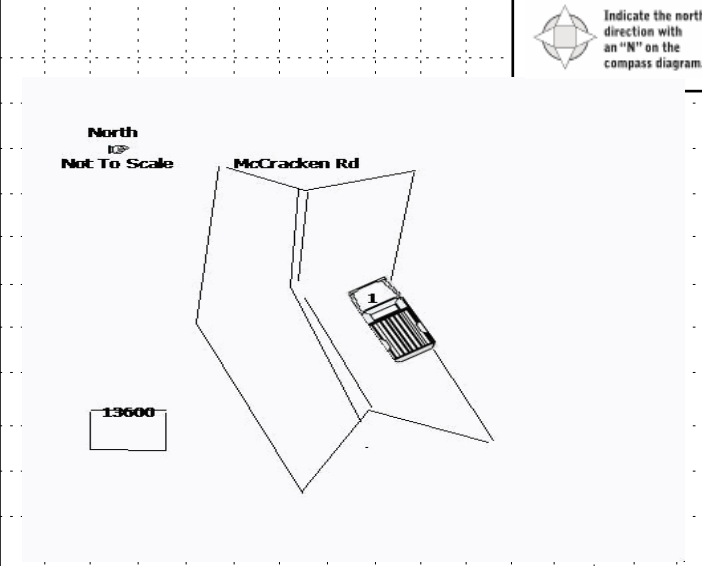

WITH A CURB. THE RIGHT FRONT COLLIDED WITH A
GUARDRAIL. UNIT#1 CONTINUED TO ROTATE AND
TRAVELED OFF THE ROAD TO THE LEFT, LEAVING THE
SCENE. IT WAS LOCATED ON MCCRACKEN NEAR
JOHNSTON AFTER LOSING CONTROL AND TRAVELING
