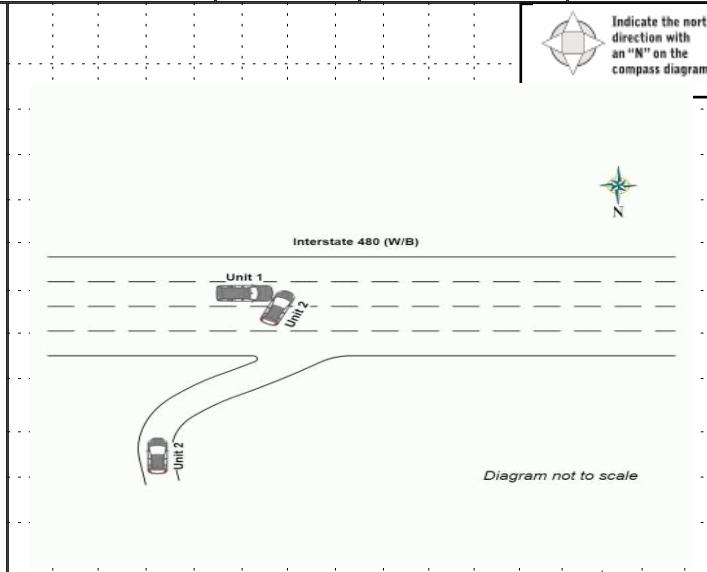

UNIT #2 FAILED TO CONTROL AND ENTERED INTERSTATE 480. UNIT #2 ENTERED UNIT #1 LANE OF TRAVEL, CAUSING BOTH UNITS TO STRIKE EACH OTHER. AFTER THE BOTH UNITS STRUCK EACH OTHER UNIT #1 WAS FORCED INTO THE GUARD RAIL ON THE SOUTH SIDE OF THE INTERSTATE.

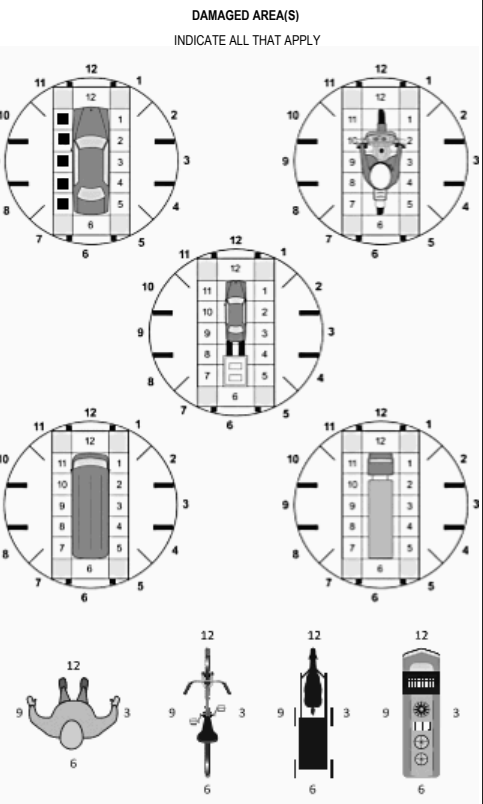
