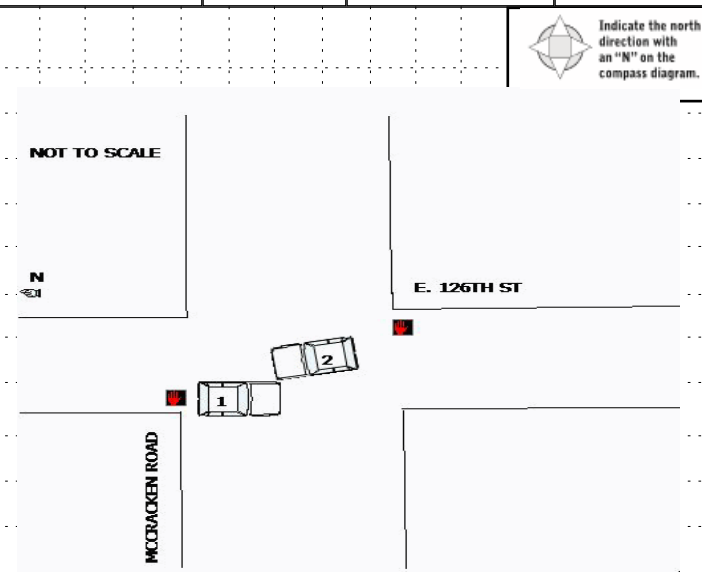

UNIT #1 WAS GOING SOUTH ON E. 126TH AND UNIT #2 WAS GOING NORTH ON E. 126TH, AND TURNING WEST ON MCCRACKEN ROAD. THE VEHICLES STRUCK EACH OTHER IN THE FRONT IN THE INTERSECTION. BOTH PARTIES ADVISE THAT THE OTHER PARTY DID NOT STOP AT THEIR STOP SIGN AND ARE AT FAULT FOR THE ACCIDENT. NO INJURIES REPORTED AND FUNCTIONAL DAMAGE TO BOTH VEHICLES.
