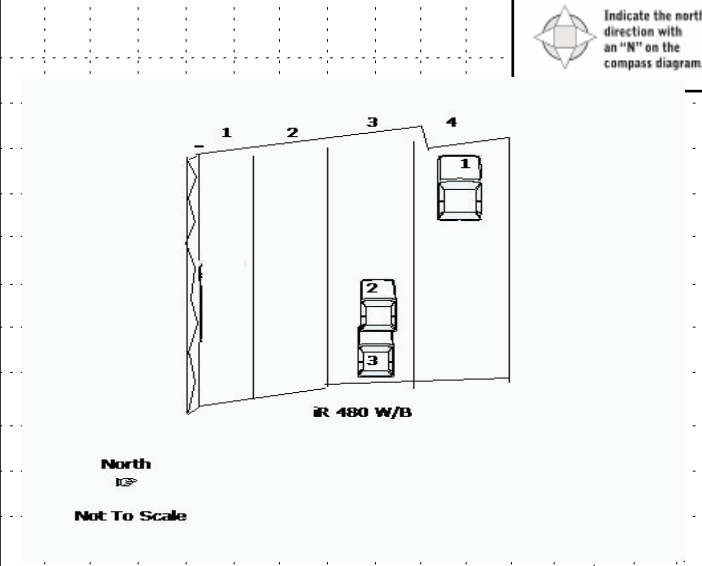

UNIT#1 LOST A LOAD. UNIT#2 TOOK EVASIVE ACTION TO THE RIGHT OF OBJECT IN ROADWAY. AS A RESULT, THE FRONT OF UNIT#3 COLLIDED WITH THE BACK OF UNIT#2. ALL UNITS WERE MOVED FROM FINAL REST. BWC


