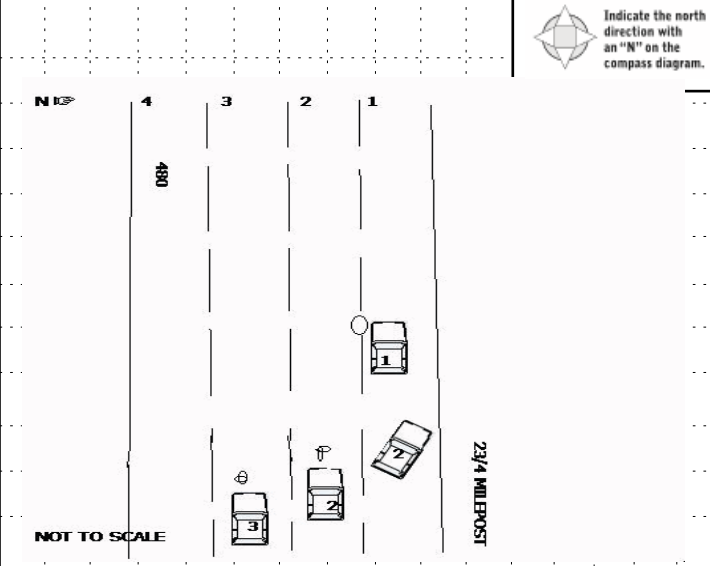

NARRATIVE  
UNIT 1 WAS TRAVELING W/B ON INTERSTATE 480 IN LANE 1 WHEN AN EQUIPMENT FAILURE OCCURRED AND LOST THE FRONT LEFT TIRE TO THE VEHICLE, CAUSING THE TIRE TO COME TO A FINAL REST IN THE MIDDLE OF THE HIGHWAY. UNIT 2 WAS TRAVELING IN LANE 2 WHEN THEY STRUCK THE TIRE THEN LOST CONTROL AND STRUCK THE GUARD RAIL. UNIT 3 WAS ALSO TRAVELING W/B IN LANE 3 AND STRUCK THE TIRE THAT WAS IN THE ROADWAY.
