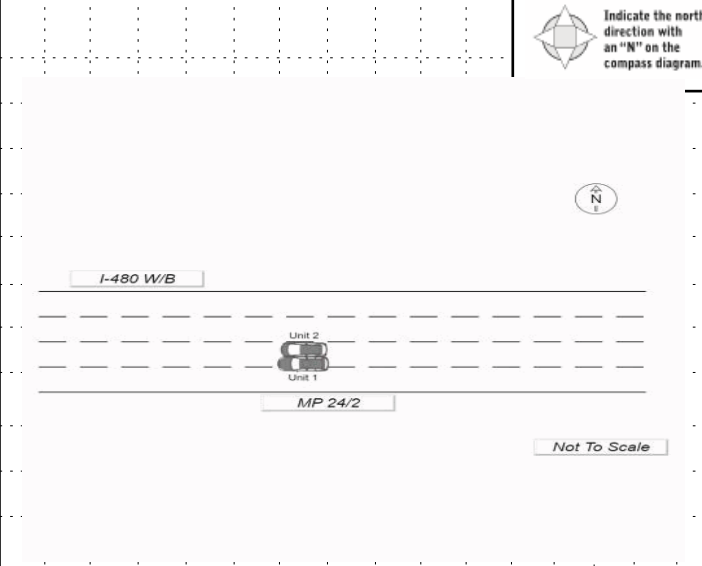

UNIT 1 CHANGED LANES INTO LANE 2 AND STRUCK UNIT 2. UNIT 1 SPUN AROUND AND CAME TO A STOP. UNIT 2 STOPPED FURTHER DOWN THE ROADWAY. SEE LONG NARRATIVE.
