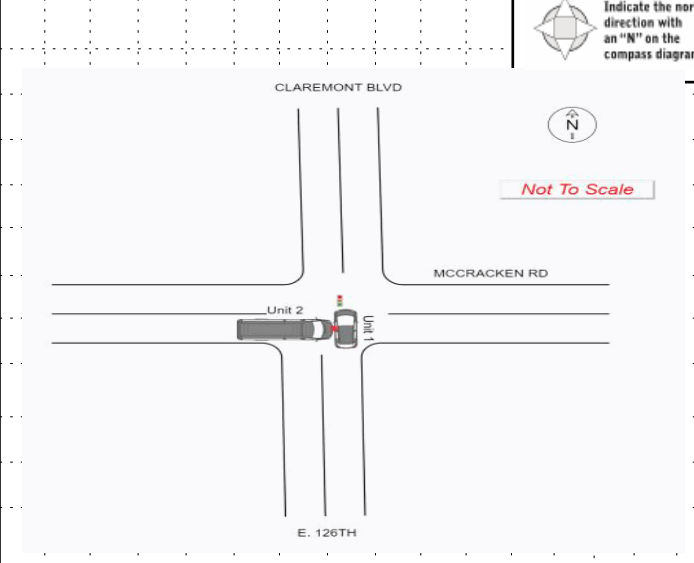

UNIT 1 WAS TRAVELING NORTH ON E. 126TH APPROACHING THE SAME INTERSECTION WITH A FLASHING RED LIGHT. UNIT 1 PROCEEDED THROUGH THE INTERSECTION, FAILING TO YIELD. UNIT 2 COULDN'T STOP IN TIME, STRIKING UNIT 1 ON THE DRIVER SIDE
