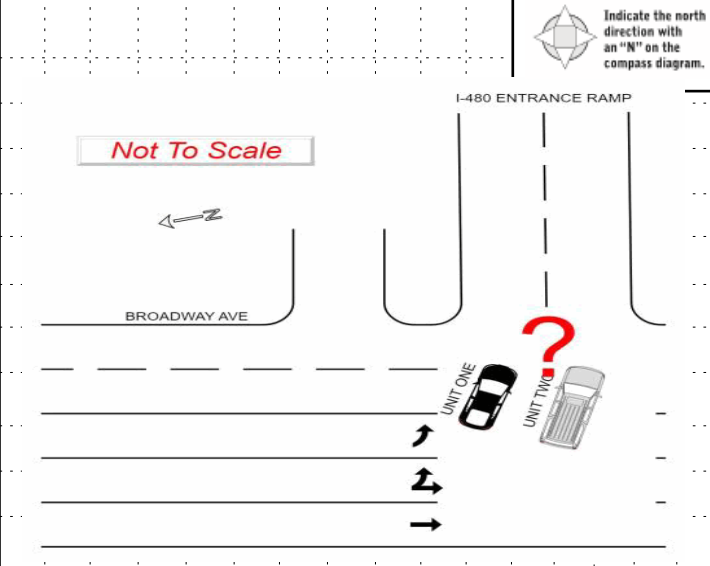

UNIT ONE WAS MAKING A LEFT TURN ONTO THE I-480 ENTRANCE RAMP FROM BROADWAY AVE IN THE FAR LEFT TURNING LANE ON BROADWAY E/B. UNIT TWO WAS TRAVELING IN THE SAME MANNER ONLY LOCATED IN THE RIGHT TURNING LANE ON BROADWAY AVE. TO I-480. WHEN BOTH UNITS WERE MAKING THE LEFT TURN FROM THEIR RESPECTIVE LANES ON BROADWAY ONTO THE I-480 ENTRANCE RAMP, THERE WAS A COLLISION THAT CAUSED MINOR DAMAGE TO BOTH VEHICLES.
